# Fire Safety Project update:

Since our last BOD meeting in January we have received a 2<sup>nd</sup> quote for a sprinkler system. We are still waiting for contractor quotes for the balconies. The architect is getting us that info as he has worked with contractors who do this type of construction. We are waiting for Spring (hopefully next month) to have a civil engineer review our property to see what would be involved in putting in a fire road.

In the meantime, we have received a fine from the fire marshal because we have not yet implemented a solution. We have appealed the fine on the basis that we are performing our proper due diligence on several possible solutions in order to bring the details, and our BOD recommendation, to ownership.
